It has 4 time programs, you can select the day, time, and duration so it is good for greenhouse watering when you want to keep it moist. The whole design slopes downward so water wont pond on top of the device. But the sealing is not very good so moisture can get into the electronic and damage it. In my case, the devise died after a storm. It worked beautifully for NINE WEEKS!! On August 15th I noticed that it had stopped working. I flushed out the filter and installed a new battery but I could no longer program the different options. It just seemed fried. I had gone away for about about 2 weeks and most of my 800 sq ft.Im really ticked off Its so awful. I just tried to return it online through Amazon, but the company policy closed the return option. I am hoping they connect with me and take this defective one back after I reorder. I am hoping they are honest and stand behind their product. Today is Aug. 25, 2016. If they dont I will definitely expand this review. To not even get one season out of this thing is horrendous. This is my favorite brand for a few reasons.

The programing is easy, they run all season long on one set of batteries with twice a day watering, and most important for me they are consistently reliable. I have had the other timers valves stick, not these. I have had others that cases cracked and let water into the electronics, not these. The only

thing that you have to be careful with is the screen. I like trouble free and reliable equipment. I have had some of these timers through 4 seasons of daily use and they still work great. I woke up the next morning to find the side of my house flooded with water as it appears the Hose end Timer had broke upon its first use. Its valve was gushing water from where the battery was placed and it had been running all night. So not only did it ruin my newly installed and landscaped yard it ran up my water bill for 12hrs of use of water and flushed out the newly layed gravel on the side of the hose that the faucet was attached. I have 3 in service and the newest is the one I got here in 2016. The other two are several years older than that, although I dont know the exact year of purchase. Each year I use 2 of these to run watering for several fruit trees I have planted and they always function flawlessly. A third I dont have them marked or anything sees use elsewhere around my property one of the other drip runs I have. Ive yet to have a failure. I also use several other timers around the place and the only thing keeping this one from being a full 5 stars for me and from being the only timer I run is the lack of a custom length manual mode. It does have a manual button but all it seems to do is just run the already set duration. Many other timers allow this but this unit does not. Anyway with what appears to be no other recourse here am now on the hunt for a replacement timer. I sent it back to Amazon and they sent me another unit.

The second unit worked fine but after a few days in the direct Florida sun, the lid over the controls became warped to the extent that once opened, it would not fully close. The hot sun had obviously caused it to deform so that the edges of the lid were curling upward. I plan to build some sort of box around it so that hopefully I can continue to use it. Im afraid that if I dont do something to give it some shade it will eventually just melt because the really hot Florida sunshine is not even here yet. Purchased three units, one failed in 4 months. Thought it was not worth the hassle of warranty so tossed it. Second product failed this spring and then I went into warranty and proof of purchase hell to get a replacement. Finally got the replacement after six weeks. Third unit failed two weeks ago. Was told that I had already had a replacement so no more allowed. That matches my experience. Very straightforward and no issues. I check the Galcon tilmer and noticed the screen was blank and water was flowing was dripping out the side casing. I took it apart and the inside was completely soaking wet and rust was starting to form on the circuit board. Something had failed and water had somehow got into the inside components and damaged it. Thinking it was just bad luck, I ordered an identical one off Amazon as there were so many good ratings. Almost two months later the EXACT same thing happened to this second unit. This is in place to identify the limit of the system, and is based on the scope agreed with the registrar to be placed on the ISO9001 certificate. This is the explanation of what your company does, be it "Design and Manufacture of Aircraft Electronics," "Machining Services for Customers in the Automotive Industry," or "Providing Fast Food for People in the Greater Pensacola Area." The second part of the scope requirement is to identify any exclusions from the standard. In addition, there is a requirement to create documented procedures when nonconformances would occur if the procedure was not written down. Simply put, if you need to have a written procedure to make sure that mistakes are not made, you need to have a written procedure. If these procedures are simply in flowchart form they could be incorporated into a short Quality Manual, but more than likely they will include some additional information, and most companies will have some additional procedures as well, so references in the Quality Manual are the simplest thing to do. This also gives you a quick place to look when trying to find a procedure. 3 A description of the interaction of processes. This is most simply done with a flowchart that identifies all the processes in the organization with arrows showing how they connect. While an indepth flowchart may help you to better understand the interactions between processes in your organization, a simple toplevel flowchart is all that is needed for most people to understand the basics. This is what is needed in the Quality Manual. Why a Short Quality Manual. The best part of a short, graphic Quality Manual is that it makes for a good brochure to explain your company to wouldbe clients. By removing most of the wordiness in a Quality Manual that comes when you simply restate the ISO9001 standard, you can include some added extras that help to sell you to people who want to buy your product.

You can include Mission and Vision statements along with your Quality Policy and Quality Objectives. Many companies ask for a Quality Manual when they are first assessing a potential supplier, and this is why making your manual an easytoread, informative brochure can be helpful. If the person assessing your manual can easily see that you have everything in place for a successful Quality Management System, then they are more likely to look further into your capabilities and capacity to fulfill their business needs. So when creating your manual, think to yourself, "What do I want customers to see" Is it a lot of words that will take some time to wade through; or would it be better to give them everything on one easy platter so that they can move on to placing an order. The Quality Manual was one of the first documents that a certification body asked for before the certification audit. How has it suddenly lost its purpose and importance. The dark side of the Quality Manual Most Quality Manuals manage to formally meet the

requirements of the ISO 9001 standard, and yet miss the point of the document. Having a Quality Manual, in my opinion, wasn't a bad idea. It is a document where the organization presents itself, its quality management system, and even its way of thinking and approach to quality management. Common practice was to besides the requirements from clause 4.2.2 include some requirements from clause 4.1 and some other requirements that were easier to document through a Quality Manual. And what is more important, such Quality Manual is useful to the management representative and process owners because it provides an overall insight into the quality management system. Big companies often require their suppliers to have a quality management system, and they may demand to see a Quality Manual during selection of suppliers. What impression does your Quality Manual give about your company. A bulky Quality Manual says that you would rather spend resources instead of applying a creative approach. See also Writing a short Quality Manual. To be or not to be With or without a Quality Manual, organizations will still need some overall QMS document. There will still be a need to send the certification body a document that will describe your system, as well as sending it to big clients. Although it's no longer mandatory, all requirements from the Quality Manual, except 4.2.2 b, remain in the new version of the standard. The scope of the OMS and interactions between the processes still need to be defined.

These requirements are even more detailed in the new version, and they still must be in some form of documented information. Same idea, different form This new nonmandatory document whatever we call it that will replace the Quality Manual will contain all remaining requirements from clause 4.2.2, and I would add some new ones. This new document should provide the following information about the organization We are XYZ company; we are producing this and providing these services; we apply a quality management system to these processes; we don't apply these clauses of the standard for these reasons; these are our processes and their interactions; and, this is the internal and external context in which we operate. This can be considered an oversimplification, and of course all this information can't be placed in just one paragraph, but this document would make sense and it would meet most of the requirements from clause 4 of the new version of the standard. Additionally, the organization's mission and vision can be added, and this document can effectively become the brochure that will introduce your company to future clients. This new version of the standard is not a slave to formality Is this a good thing.
